Payments are subject to income tax and national insurance which can result in either a deduction or a credit.

Travel and Subsistence payments are paid at rates determined by Scottish Government.

Telephone Allowances The element of Councillors' telephone expenses that relates directly to their duties as a Councillor is reimbursed.

Official Council Car . The costs relating to SL1 being used as the official car are shown in column (F) . The Council car is not used for purposes other than official duties .
