Age	Yes	The Safe Drive Stay Alive (SDSA) roadshow targets young people in S4 delivering hard hitting road safety messages. While young people account for ten per cent of all driving licence holders, they are involved in 20% of accidents. Young drivers are still developing their skills. Their age and lack of experience put them in a very at-risk group. That means they are much more likely to be involved in an accident than an older driver. Single-vehicle accidents are common among young drivers. Often they are the result of the driver losing control. The high rate of accidents means young drivers pay more for car insurance. There were no fatalities on Clackmannanshire's roads between 2012-2016.
