Elected Members' Remuneration, Allowances and Expenses 2020/21

Basic Allowance: This is determined by reference to Local Governance (Scotland) Act 2004 (Remuneration) Regulations 2007, as amended.

Remuneration Payments for Elected Members: These are determined by reference to Section 11 (14) of the Local Governance (Scotland) Act 2004 (Remuneration) Regulations 2007. From May 2007 special responsibility allowances have been paid to the Leader of the Council, the Provost and 8 elected members with significant responsibility. The rates are set at levels recommended by the Scottish Local Authorities Remuneration Committee. Payments are subject to income tax and national insurance which can result in either a deduction or a credit.

Travel and Subsistence payments are paid at rates determined by Scottish Government.

Telephone Allowances: The element of Councillors' telephone expenses that relates directly to their duties as a Councillor is reimbursed.

Official Council Car: The costs relating to SL1 being used as the official car are shown in column (F) . The Council car is not used for purposes other than official duties .
