## Civic Government (Scotland) Act 1982 Guidance Notes - Street Trader Licence Application

- The application must be accompanied by the relevant fee. Application fees are non-refundable. If after receipt of the application form it is determined that the relevant fee has not been properly paid, e.g. cheque returned by the bank, the application will be rendered void and will be returned to you.
- One passport photograph signed on the reverse should accompany your application.
- The enclosed Certificate of Compliance requires to be completed and returned to the Licensing Section where the proposed trading involved food business using a vehicle, kiosk or moveable stall. A Certificate of Compliance must be obtained from the local authority where your business is based.
- Your attention is drawn to the standard conditions attached to this application which are as noted on the enclosed Schedule.
- The Licensing Committee may attach additional conditions to the licence as it sees fit, with each application being dealt with on its own merits.
- (If appropriate) Once we have received your Application, we will send a copy to Scotland Police. We will also consult with other Council Services, for example Environmental Health, Building Control, Roads, etc., depending on the nature of your application.
- (If appropriate) If we think any additional enquiries should be carried out, you will be notified and the results of these may be taken into account before we decide your application. We will also require to take account of any objections to your application, either from consultees or from members of the public. We may decide to hold a Hearing to decide whether to approve your application and, if so, you will be notified in advance of this to give you an opportunity to be heard.
- We can refuse your application if we consider that:
  - a) you are not a fit and proper person to hold a licence,
  - b) the premises are not suitable or convenient for the proposed activity and if
  - c) there is any other good reason to refuse your application.
- When an application is refused, you can ask for written reasons for the refusal and you have a right of appeal to the Sheriff.
